Resolution No 49

of the Council of International Environmental Doctoral School associated with the Centre for Polar Studies at the University of Silesia in Katowice (MSSD) on 15 April 2021 regarding the schedule of mid-term evaluation in the academic year 2020/2021

Pursuant to Par. 4 Section 6 (4) of Resolution no. 306 of the Senate of the University of Silesia in Katowice of 27 November 2018 regarding specifying the Rules and Regulations of the International Environmental Doctoral School associated with the Centre for Polar Studies at the University of Silesia in Katowice (MSSD) (i.e. as adopted in the Appendix no. 3 to the Resolution no. 391 of the US Senate of 28 May 2019) and **Par. 3 Section 1 of Resolution no. 46 of the Council of International Environmental Doctoral School associated with the Centre for Polar Studies at the University of Silesia in Katowice of 18 March 2021 regarding the organisation of mid-term evaluation of doctoral students of MSSD**, the Council of MSSD hereby adopts the schedule of mid-term evaluation in the academic year 2020/2021:

Par. 1

The mid-term evaluation of the International Environmental Doctoral School associated with the Centre for Polar Studies at the University of Silesia in Katowice in the academic year 2020/2021 shall be held on the following dates:

31 August 2021 - deadline for submission of reports on realization of the IPB (Individual Research Plan) through the website of MSSD and in a hardcopy format at the office of MSSD;

20 September 2021, between 9:00 am and 3:00 pm - deadline for an open scientific seminar during which the assessed doctoral students of MSSD, in an alphabetic order, will present progress in realizing IPB and the level of their research project advancement (the first stage of mid-term evaluation).

21 September 2021, 9:00 am to 5:00 pm - closed session of the Committee on Mid-term Evaluation and interviews with doctoral students, supervisors and assistant supervisors, at the request of the Committee members, doctoral student or supervisors (the second stage of the mid-term evaluation) and the term of the confidential session of the Committee for Mid-term Evaluation (the third stage of mid-term evaluation); separate sessions of the Committee in each of the disciplines represented by the doctoral students subjected to the mid-term evaluation are held during that time.

24 September 2021 - date of announcing the results of the mid-term evaluation.

The decision as to the form, and in case of direct form also as to the place, is undertaken by the Dean of MSSD by way of an ordinance, no later than 3 months prior to the term of the seminar and of the sessions of the Committee.
