

Regulation no 1/2024

of the Dean of the International Environmental Doctoral School (IEDS) associated with the Centre for Polar Studies at the University of Silesia in Katowice of 29 January 2024 on the announcement of the recruitment schedule at IEDS in the academic year 2024/2025.

Pursuant to 6(1) of Regulation no. 493 of the Senate of the University of Silesia in Katowice of January 23, 2024 on recruitment requirements and the mode of recruitment to the International Environmental Doctoral School (IEDS) at the Centre for Polar Studies at the University of Silesia in Katowice in the academic year 2024/2025, I order the following:

Recruitment schedule at the International Environmental Doctoral School associated with the Centre for Polar Studies at the University of Silesia in Katowice in the academic year 2023/2024

1. June 27, 2024 — opening an online registration for candidates through the online candidate registration system (irk2.us.edu.pl).
2. August 23, 2024 — closing of online registration for candidates.
3. August 23, 2024 — deadline for submitting the outline of the doctoral project, list of candidate's scientific achievements form, documents confirming scientific achievements and other documents
4. September 2, 2024 – evaluation of the outline of doctoral projects (1 st stage of the recruitment procedure) and assessment of the scientific achievements of the candidates (2nd stage of the recruitment procedure) by the recruitment committee.
5. September 3, 2024 – providing candidates with information about the results of the 1st and 2nd stage of recruitment and the admission or non-admission interviews, as well as notification of the date and place of interviews.
6. September 4-5, 2024 – interviews with candidates (3rd stage of the recruitment procedure).

7. September 6, 2024 – notification of candidates about the recruitment results.
8. September 9-10, 2024 – receiving documents from candidates qualified for admission and entering them on the list of doctoral students.
9. September 11, 2024 – notification of admission to candidates on the reserve list.
10. September 12, 2024 – receiving documents from candidates qualified for admission from the reserve list and entering them on the list of doctoral students.
11. September 13, 2024 – the date of announcing the results of the recruitment procedure on the IEDS website.
